Dear CCCC Colleagues,

The Veterinary Medical Technology department would like to invite you to participate in the small animal clinics portion of our Spring Clinical Practices III course. During these clinics, students gain experience working with VMT faculty on routine cases that are typically seen in veterinary clinics. We currently have appointment openings in our surgical, medical, and dental rotations. Appointments are made on a first come, first served basis, until all appointment slots are filled.

What services are available? And, what do they cost?

The following are the routine services that we provide for these rotations and the prices charged for each:

Surgery

Spays and Neuters for dogs under 75 pounds, \$65 over 75 pounds, \$130 Spays for cats (\$50) Neuters for cats (\$40)

<u>Medical</u>

Rabies vaccinations for dogs and cats (\$10) Distemper, Parvo, Leptospirosis vaccinations for dogs (\$20) Bordatella (kennel cough) vaccination for dogs (\$20) Feline Leukemia vaccinations for cats (\$25) Feline distemper vaccinations for cats (\$20) Heartworm testing (\$20) Feline Leukemia testing (\$40) Ear cleaning for dogs and cats (\$15) Toe Nail Trims (\$15) (sedation will be extra)

Dental Cleaning (no extractions, etc.) (\$75)

How do I schedule an appointment for my pet?

You can schedule an appointment by contacting Jonathan Loftis, at 919-718-7465, or stopping by his office in the VMT Building on the Lee campus. Appointments are available on a first come, first served basis. Space is limited.





What do I need to have at the time of scheduling an appointment?

At the time you schedule your appointment, you must provide:

- proof of current rabies vaccination (unless the animal is a puppy or kitten coming for the first rabies vaccine)
- cash payment of the fees associated with the procedures you are requesting will also be collected at this time, and
- the attached forms, will need to be completed and submitted at this time as well

When are appointments available?

The clinics are operated on Mondays and Wednesdays only, during the Spring semester.

When time will I need to have my animal in Vet Med by?

Animals brought in for these appointments must be in Vet Med for check-in <u>no later</u> <u>than 7am</u> on the day of their appointment. This provides time for initial exams, catheter placement, pre-surgical blood work, etc. to be performed prior to students' 8am classes.

When will my animal be available to take home?

Pets will be available for check-out at <u>4pm</u> on the day of their appointment. If you need to pick your pet up a few minutes later, PLEASE make prior arrangements with Jonathan Loftis. Sorry, no "sleep overs" are available. ⁽¹⁾

What type of services are NOT available?

Due to the federal regulations that govern our program, we do not operate as a fully active or staffed veterinary hospital, therefore we do not offer services for sick, debilitated, and/or injured animals. For these types of cases, please see your regular veterinarian or the closest available emergency clinic.
